Nevada Revised Statute (NRS) 388G.660 Reporting Requirements

Nevada Revised Statute (NRS) 388G requires that certain information be established by January 15 of each year and that, subsequently that information is posted online and made available to the public:

(a) The estimated total amount of money to be received by the large school district from all sources, including any year-end balance that is carried forward, and shall identify the sources of such a year-end balance and whether the year-end balance is restricted. If the year-end balance is restricted, the superintendent shall identify the source of the restriction and the total of amount of money to be received by the large school district that is unrestricted.
